Re: Interpretation of Texas Government Code § 551

Dear Attorney General Paxton,

With this letter, I respectfully ask that you provide a formal written opinion regarding the following issues.

Background

The Hood County Hospital District ("District") is set up under Chapter 1042 of the Texas Special District Local Laws Code. Such special districts are considered governmental bodies under Chapter 551.001(3)(H) of the Texas Government Code. They are thus subject to the Texas Open Meetings Act under that chapter.

The District posted notice on November 9, 2023, of their meeting to be held on November 17, 2023. (See Exhibit A.) This notice was not amended. Underneath the listed agenda items was a list of reasons why the District might adjourn into executive session.

On November 13, 2023, Hood County Judge Ron Massingill, a member of the District board, sent notice to other board members that the District would convene into executive session at the November 17 meeting to discuss hiring a law firm. (See Exhibit B.) On the date of this letter, the District had sufficient time to amend the agenda to include this item with at least 72 hours' notice, according to Chapter 551.043 of the Government Code.

On November 16, 2023, I notified the judge that the proposed item was not on the agenda, and that the District should not take up that item since it wasn't posted. (See Exhibit C.) The judge, after conferring with District board president Christy Massey, responded that the District would proceed with the executive session the following day.

On November 17, 2023, the board did in fact convene into executive session. Two board members objected and left the meeting, but a quorum moved forward. (See Exhibit D.) President Christy Massey stated that the language at the bottom of every District agenda allows the District to convene into an executive session without additional notice.

Question 1

Is it proper for a governmental body to convene into executive session to discuss a tax rate election and hiring a law firm to facilitate this process, as outlined in Exhibit B? Under Chapter 551.071 of the Texas Government Code, the language states an executive session may be proper in some circumstances for a governmental body to conduct a private consultation with *its* attorney. (Emphasis added.) Does a discussion to hire a law firm fit under any provision under § 551.071?

Question 2

Does the boilerplate language at the bottom of each agenda allow the District to convene an executive session during any meeting without additional notice? Is this adequate notice under § 551.041? Your office has repeatedly opined that governmental bodies must give notice of agenda items, including executive session items. See Tex. Att'y Gen. Op. JC-0057 (1999); Tex. Att'y Gen. Op. GA-0511 (2007). These opinions have tracked case law in Texas dating back at least as far as *Cox Enters., Inc. v. Bd. of Trs.*, 706 S.W.2d 956, 958 (Tex. 1986). Other opinions have stated similar things. For instance, "The Act also requires advanced written notice of all meetings held by a governmental body. Tex. Gov't Code Ann. § 551.041. The notice requirements also apply to executive sessions, and the notice must be sufficiently specific to alert the general public to the topics to be considered." *Weatherford v. City of San Marcos*, 157 S.W.3d 473, 485 (Tex. App.--Austin 2004).

Thank you for your attention to these questions. We look forward to hearing your response.



4.3.1 Judge Massingill reported that he received a letter from Gary Kitchens, the Vice President with First National Bank of Granbury, that handles investments regarding a \$850,000.00 treasury note that is coming due at the end of January 2024. The letter states that the First National Bank of Granbury has pledged \$3,000,000.00 bond that will cover the hospital funds that we keep in the bank. The amount is currently covered under \$250,000.00 by FDIC. The pledge will now cover over the \$250,000.00.

Judge Massingill reported that the Hood County Hospital District currently has an investment consisting of five securities with the par value of \$1,915,000.00. There are also two US Treasury notes and three agency bonds. These investments will mature in 2024 and 2025.

<u>Action:</u> A motion to accept Judge Massingill's report was made by Terry Stamper and seconded by Dr. Kuban. Motion carried 9-0.
