## PLAINTIFF THE STATE OF TEXAS'S NOTICE OF APPEAL

Plaintiff the State of Texas ("Texas"), by and through the Office of the Attorney General of Texas, appeals the Court's Order denying Texas's Application for a Temporary Restraining Order, and Temporary Injunction.

Texas is entitled to an interlocutory appeal pursuant to Tex. Civ. Prac. & Rem. Code §§ 51.014(a)(4), (8), which allow for immediate appeals from orders denying temporary injunctions. Texas appeals to the Fifteenth Court of Appeals of Texas. This is not a parental termination or child protection case, as defined in Tex. R. App. P. 28.4.

Pursuant to Tex. Civ. Prac. & Rem. Code § 6.001, as a governmental entity, Texas is not required to file a supersedeas bond for court costs. Texas's appeal is therefore perfected upon the filing of the notice of appeal.
