I am writing this letter to respectfully request an Attorney General's Opinion regarding Article 5, Section 18, Paragraphs C and D of the Texas Constitution, concerning changes in precinct boundaries for certain elected officials. This letter is a follow-up to an identical request submitted by a constituent of Representative Domingo Garcia, Dallas County Justice-of-the-Peace Luis Sepulveda, which was denied.

The focus of the opinion should be on whether an official elected for a four-year term can be forced to run for re-election the following year because of redistricting.

Dear Mr. Dahill,

In regards to our telephone conversation I am requesting the following information and an Attorney General's opinion on the appointment of Justice of the Peace and Constables. Referencing Section 18, Article 5, Paragraphs C and D of the Texas State Constitution, I would like an opinion on the legality of requesting recently elected officials to resign and be appointed to the new precincts. There are several elected officials who have taken office January 1, 2001 for a four-year term. It is my understanding if the appointment is rejected on October 1, 2001; those elected officials will remain in office until the expiration of their four-year term. At this time, I am requesting in writing the ramifications of not accepting the appointed position and serving out the remainder of my four years. If I am displaced to another location for the next four years will my chief clerk, bookkeeper and staff also be assigned to this location? How will this action impact the constituents that elected me to represent them for four years? Will they still be able to file in my new location and will I have the staff to assure them a speedy trial and the professionalism that my current staff has displayed? How can I be assured there will be no retaliation on budget cuts, if I decide to not accept the appointment and serve my four years in a new location? It has been an uphill battle since January 1, 2001 when taking office at a court that the people no longer believed in because of the previous administration. I was elected to represent the citizens of Precinct 6, which will become Precinct 5 on October 1, 2001 and I feel a deep commitment to continue to represent them no matter what the situation may become.

I respectfully request a timely response to the Attorney General's opinion and the various questions presented in this letter.
