Honorable Texas Attorney General Ken Paxton,

I am the County Attorney of Rusk County serving by operation of Art. 2.02 of the Code of Criminal Procedure as the District Attorney for the 4th Judicial District. I am therefore authorized to seek an opinion. I thank you for your consideration of the foregoing request in advance.

An officer, employee, or official of a county government who refuses to comply with this subchapter commits an offense. Local Government Code 111.012

What culpable mental state does the word, "REFUSES" as used in Local Government Code 111.012 require in terms of *mens rea* for a criminal prosecution, that is to say what evidence of such *mens rea* would be legally sufficient?

There is no penal code definition of "refuses". The dictionary definitions, such as the ones set forth in exhibit A, denote a "refusal" occurs after a request has been tendered. For example, he refused to answer the question implies a question was asked. Texas Penal Code 6.02 mandates use of the *mens rea* proscribed in the statute. Such implies a timely request for compliance must be proven to support a legal finding of "refuses". However, such is inconsistent with a basic maxim of

western jurisprudence: A person may be ignorant of the law, but the rule is, that such ignorance does not excuse him.... Blackstone's Commentaries.

- 1. - 2. Posted on Courthouse doors by 10:00 a.m. on the 16th day of August, 2021 is a public notice for an August 19, 2021 at 10:00 a.m. regular meeting agenda inter alia setting forth Item #2 "Discuss and possibly approve the adoption of the Rusk County Budget for the year 2022...." And Item #3 Vote for or against the adoption of the 2022 Rusk County budget. See exhibit C
- 3. On August 24, 2021, a budget certificate is file marked reciting, "... the attached budget is a true and correct copy of the budget of Rusk County as passed and approved by the Commissioners Court of said County on the 19th day of August, 2021" Subscribed and sworn to by the county judge and auditor before the county clerk. See exhibit D
- 4. Local Government Code 111.007 (c) recites in pertinent part the commissioners court shall give notice of public hearing on the proposed budget not later than the 10th day before the hearing on the proposed budget. See exhibit E
- 5. Local Government Code 111.012 An officer, employee, or official of a county government who refuses to comply with this subchapter commits an offense. Subsection b sets out a punishment of up to a thousand dollar fine and one year in county jail.
- 6. The forgoing facts and exhibits support a prima facie violation of 111.007(c) because 3 days' notice was provided instead of the required 10

even if one assumes the meeting agenda amends and supersedes the previously noticed meeting of September 13.

My concern is the possible criminal enforcement, not the civil ramifications of a void or voidable budget. I do not undertake to advise the Court in such regard because it might conflict with my criminal enforcement obligations.





(b) The copy of the proposed budget shall be available inspection by any person. If the county maintains an ternet website, the county clerk shall take action to ensure that the proposed budget is posted on the website.

Sec. 111.007. PUBLIC HEARING ON PROPOSED BUDGET. (a) The commissioners court shall hold a public hearing on the proposed budget. Any person may attend and may participate in the hearing.

- (b) The commissioners court shall hold the hearing not later than the 25th day after the day the budget is filed under Section 111.006 but before the commissioners court adopts the county's ad valorem tax rate for the current tax year.
- (c) The commissioners court shall give public notice that it will consider the proposed budget on the date of the hearing. The notice must state the date, time, and location of the hearing. The notice must include, in type of a size at least equal to the type used for other items in the notice, any statement required to be included in the proposed budget under Section 111.003(b). The commissioners court shall give notice under this subsection:
- (1) not earlier than the 30th day before the date of the hearing; and
- $\left(2\right)$ not later than the 10th day before the date of the hearing.

Sec. 111.011. CHANGES IN BUDGET FOR COUNTY PURPOSES.

s subchapter does not prevent the commissioners court from aking changes in the budget for county purposes.

Sec. 111.012. PENALTY. (a) An officer, employee, or official of a county government who refuses to comply with this subchapter commits an offense.

(b) An offense under this section is a misdemeanor punishable by a fine of not less than \$100 or more than \$1,000, confinement in the county jail for not less than one month or more than one year, or by both fine and confinement.

Sec. 111.013. LIMITATION ON BUDGET OF COUNTY AUDITOR. An increase from one fiscal year to the next in the amount budgeted for expenses of the county auditor's office or the salary of an assistant auditor shall not exceed five (5) percent without approval of the commissioners court.

Sec. 111.014. RESERVE ITEM. Notwithstanding any other provision of this subchapter, a county may establish in the budget a reserve or contingency item. The item must be included in the itemized budget under Section 111.004(a) in the same manner as a project for which an appropriation is established in the budget.
