I am Patricio Hernandez Owner and operator of Grande Garbage Collection Co., LLC. (GGCC). I am writing to you to ask for your assistance in securing a legal opinion from the Texas Attorney General's Office concerning the following matter:

The City of Escobares, Texas, is a legally incorporated city within the geographic boundaries of Starr County, Texas. It owns and operates a trash collection service for its constituents.

GGCC is a privately owned and operated company offering and providing trash collection services to all Starr County citizens except for those within the City of Escobares.

The dilemma: The City of Escobares is currently offering trash collection services outside of their geographic boundaries and using public funds to operate equipment, personnel and billing expenses. This has hurt GGCC and/or will actively hurt other privately owned companies within the area if The City of Escobares is allowed to continue with their business practices.
