Subject: Whether the Village of Salado may reduce the Local Option Homestead Exemption

Representative Buckley,

The Village of Salado, Texas (the "Village") appreciates your time and consideration of a matter that is very important to the Village and its residents. The Village respectfully requests that, pursuant to your authority under Texas Government Code § 702.042(b)(7), you request an opinion from the Attorney General of Texas regarding the following question of public interest:

The Village has adopted a Local Option Homestead Exemption ("LOHE") which was in place in 2022. Pursuant to Tax Code § 11.13(N-1), a LOHE in place in 2022 cannot be repealed until the December 2027 expiration of § 11.13(N-1). During the May 5, 2025 election, voters in the Village will consider a petition pursuant to Tax Code § 26.075(c) to call a special tax election to reduce the tax rate adopted by the Village Board of Aldermen for the Fiscal Year 2024-25 to the voter-approval tax rate. If adopted by the voters, the petition will reduce the Village's property tax rate from \$0.4860 per \$100 of valuation to \$0.3612 per \$100 of valuation. If the voters approve the petition to reduce the Village's adopted tax rate to the voter-approval tax rate, in order to fund essential municipal services including the provision of police protection, may the Village reduce the LOHE for Fiscal Year 2025-26?
